Enrollment Procedure and Schedule

The chart below outlines the enrollment process and timeline. Depending on enrollment numbers, signing up for a class does not guarantee a spot in that class. All families will be notified of their child's enrollment status the week of April 11.

January 13 - February 4	<p>Official enrollment period takes place.</p> <ul style="list-style-type: none"> • Registration forms, residency approval and the \$300 deposit must be submitted. • Priority will be given to those who register first. • Residency will need to be established for each new student to our school. Registration is contingent on approved residency. Residency approval prior to registration will help secure your preferred spot. Originals of birth certificates and current residency documentation are required. • Physicals dated after September 1, 2010 are required before the first day of school. • If a student is currently in our preschool, a \$300 deposit plus the Enrollment Form are all that is needed. No medical physical, proofs of residency, or registration paperwork will be required.
Starting February 28	Classes are formed based on the enrollment numbers. If more students are enrolled than the class maximum, parents may be called to switch to another section. If enrollment does not exceed seven students, the class will be cancelled and second requests will be honored as available.
Week of April 11	All parents who register a preschooler are officially notified by mail of their child's enrollment status.
April 19	Security deposits will be deposited and become non-refundable .
May 20	Full tuition for 1 st semester and registration forms are due.
November 2011	Invoices for 2 nd semester are mailed.
