

Minutes of the General Meeting of the Pleasantdale PTA

Wednesday, September 7, 2011

President, Jennifer Hennessy, called the meeting to order at 5:48 p.m.

All in attendance recited the Pledge of Allegiance.

President, Jennifer Hennessy, welcomed attendees and introduced the other members of this school year's Executive PTA Board: **Jennifer Hawbaker, Vice President; Ann Marie Daker, Vice President; Dawn Parente, Treasurer; and Dania Mahoney, Secretary**.
